

YEAR-WISE ACCOUNT OF ACTIVITIES SUPPORTED BY ROBA TRUST SINCE ITS INCEPTION

Financial Years 1994-95 to 1996-97

During financial years ended 31.03.1995, 31.03.1996 and 31.03.1997, a period of three financial years, the Trust was receiving monies promised from Old Boys, registering and obtaining approval from Income Tax Authorities.

The first instalment of the contribution from KCMET amounting to Rs.4 Lacs was received in 1997. With this the total sum available with the Trust reached a figure of Rs.11,28,108.00. Two scholarships of Rs.10,000.00 each were awarded from monies received from KCMET funds.

Financial Year 1997-98

Rs.1 lac was received for Lalwani Fund and a further Rs.1,72,569/- from Old Boys.

From the monies received to date, seven scholarships of Rs.10,000 each were awarded. Six were from KCMET Corpus funds and one from Lalwani Trust. Besides this, Rs.25000/- was spent on School Masters welfare in terms of facilities. Rs.76,900/- was spent on Publications/ Periodicals.

Financial Year 1998-99

A further sum of Rs 2,66,666.00 was received from KCMET and Rs.24,590 from Old boys.

Rs.80,000.00 was spent on Scholarships, 11 from KCMET funds and one from Lalwani Trust. Besides this other expenditure of Rs.49000/- was incurred on various activities.

Financial Year 1999-2000

Rs 2,66,666.00 was received from KCMET and a further sum of Rs.20,510/- was contributed by the Old boys.

15 scholarships of Rs 10,000.00 were awarded, 14 from KCMET and one from Lalwani Trust. Rs.50,000/- was spent on RIMC Masters/ Staff welfare and Rs.49,500/- on publications. Rs.37,500/- was paid towards meeting the expenses for School Masters' requirement of additional reading material for professional improvement.

Financial Year 2000-01

Rs.1,03,308.00 was received from Old Boys and another Rs.2,66,666.00 from KCMET.

An amount of Rs.90,000.00 was paid on account of extreme welfare measures to an old cadet and Rs.10,000.00 each for scholarships to 17 cadets, 16 from KCMET and one from Lalwani Fund. Rs.26,150.00 was paid for publications and periodicals. Rs.37,500.00 was paid towards meeting expenses for School masters' requirement of additional reading material for professional improvement.

Financial Year 2001-02

An additional sum of Rs 2,17,946.00 was received.

Scholarships amounting to Rs.2,00,000/- were awarded @ Rs.10,000.00 each to 19 cadets from KCMET funds and one from Lalwani Fund. Rs.28,900/- was paid for the welfare of staff.

The parents of a 12 year old cobbler's son, left an orphan due flash floods, was paid a one time grant. Rs.24,750 was paid as honorarium to another staff member. Publication/periodicals expenses of Rs 13,800.00 were also incurred.

Financial Year 2002-03

A sum of Rs.87,752/- was received during the year.

Scholarships amounting to Rs.2,10,000/- were awarded @ Rs.10,000.00 each to 20 cadets from KCMET funds and one from Lalwani Fund. Rs.60,300/- was paid for the welfare of RIMC staff.

Publication/periodicals expenses of Rs.33,900.00 were also incurred.

Financial Year 2003-04

An additional sum of Rs.43,00,859/- was received during the year including Rs.40 lacs from SDTT.

Scholarships amounting to Rs.1,23,000/- were awarded from KCMET funds.

In addition, a humanities stream was founded at RIMC and two teachers were selected and posted for the purpose. They were paid a remuneration of Rs.1,12,000/- during the year out of SDTT funds.

A sum of Rs 45,000/- was paid for the exchange program to Australia.

A sum of Rs.33,900/- was spent on publications whereas the expenses on cadets' welfare and masters' welfare amounted to Rs.34,000.- and Rs.37,800/- respectively.

Financial Year 1-4-2004 to 31-3-2005.

A sum of Rs.2,13,079/- has been received during the year.

Scholarships amounting to Rs.80,000/- have been awarded, including one each from SDTT fund and Chanda Devi fund..

In addition, the two teachers have been paid a remuneration of Rs.96,000/- during this period out of SDTT funds.

A sum of Rs 45,000/- has been paid for an exchange program to Australia.

A sum of Rs 10,000/- was paid towards relief for a Class IV employee needing constant dialysis.

Financial Year 1-4-2005 to 31-3-2006

A sum of Rs.5,72,218/- has been received during the year.

Scholarships amounting to Rs.1,32,000/- have been awarded, including one each from SDTT fund and Chanda Devi fund..

In addition, the two teachers have been paid a remuneration of Rs.1,50,250/- during this period out of SDTT funds.

A sum of Rs 40,000/- has been paid for an exchange program.

A sum of Rs 27,000/- was paid towards grant and incentive to Class IV employees.

A sum of Rs 21,600/- was paid towards RIMC Masters' Book Allowances.

Financial year 1-4-2006 to 31-3-2007

A sum of Rs.5,04,170/- has been received during the year.

Scholarships amounting to Rs.95,500/- have been awarded, including one each from SDTT fund and Chanda Devi fund..

In addition, the two teachers have been paid a remuneration of Rs.2,32,250/- during this period out of SDTT funds.

A sum of Rs 34,400/- has been paid for RIMC cadets.

A sum of Rs 18,000/- was paid towards incentive to Class IV employees.

A sum of Rs 21,600/- was paid towards RIMC Masters' Book Allowances.
